The Regular Meeting of the Board of Trustees was called to order at 6:34 p.m. by Roger Bañuelos, President, in the District Board Room.

Ms. Shavonda Christmas and Mr. Bill Magoon shared information regarding the Choice Block issue to be held at Leuzinger High School and Dana Middle School on March 2, 2015.

Mr. Wilson provided the Board with an update on the length of the lunch lines at Dana Middle School. Chartwells has started strategies to shorten the lunch lines. One is providing signs with the menu selections so kids can decide ahead of time. They are also making some other minor adjustments that have facilitated a faster delivery of lunches to Dana Middle School students.

From the Chief Business Official

Dr. Jones provided the Board with an update on the Emergency Generator Plan in the event that we have power outages in the community and the impact that this has on our technology infrastructure. We have revised the protocol for back-up power for both shutdown and the restoration of power. The District has also purchased unit back-ups for surge protection to protect our very significant investment in technology systems.

Dr. Johnstone provided immunization rates from all of our schools at the request of Trustee Mora. All Wiseburn schools maintain an average of 97% of the students being immunized.

Dr. Johnstone shared that he, Vince Madsen, Nathan Kim and Tom Williams had met with the fire-life-safety principals at the Department of the State Architect (DSA) and that we are much closer to agreement in terms of fire-life-safety issues for the Wiseburn High School Project.
