REGULAR MEETING BOARD OF TRUSTEES WISEBURN SCHOOL DISTRICT

October 27, 2011

The Regular Meeting of the Board of Trustees was called to order at 7:06 p.m. by Dennis Curtis, President, in the District Board Room.

The Pledge of Allegiance to the Flag was led by Ms. Dulce Stein.

Ms. Maria Garcia made a presentation about Northrop Grumman Space Camp in Huntsville, Alabama. Ms. Garcia and two 8th grade students, Sam Jussen and Malissa Crise, provided a very interesting presentation of their experience in Huntsville, Alabama. The students participated in simulations that included a mock space shuttle flight and a visit to the Space Station. The experience in Huntsville, Alabama, challenged both of the students and Ms. Garcia intellectually and physically and for all three it was a lifetime experience. Also, present for the presentation was Phyllis Glock from Northrop Grumman. Phyllis was recognized by the Board for her outstanding dedication and contribution to Dana Middle School over the past several years.

Special Presentation

Ms. Glock was also very instrumental in nominating 8th Grade Science Teacher, Kris Torrey and 7th Grade Math Teacher, Maria Garcia for the Zero Gravity Flight over the Pacific, also affectionately known as the "Vomit Comet." Northrop Grumman nominates 60 teachers per year, 30 on the East Coast and 30 on the West Coast to participate in this flight over the ocean. Ms. Torrey and Ms. Garcia were two of the 30 teachers selected from California and Nevada.

To conclude the presentation by Dana Middle School teachers, Ms. Aileen Harbeck and Ms. Maria Garcia presented the Board with an overview of Google applications. Dana Middle School is working on digital portfolios for every student in the coming year. Several teachers and their classes are piloting the digital portfolios and the closed system e-mail this year. The closed system enables Dana Middle School students to communicate with their teachers and each other but no e-mail can go outside of Dana Middle School or come into Dana Middle School from the outside.

Dulce Stein thanked the Board and the District for supporting all of her projects and reminded the Board and the audience of the field trip to the Tim Burton Exhibit at the Los Angeles County Museum of Art (LACMA) on October 30th. Dulce presented the Board and audience with baked treats.

From the Public

Ms. Andriacchi mentioned that one of our active parents, Shavonda Christmas, who is one of our Chief Petitioners and also a member of the 7/11 Committee, has an injury prevention program that she would like to present to the Board in the future.

From the Board

Ms. Andriacchi mentioned that there still seems to be some traffic and congestion problems around the schools and she was still receiving some expressions of concern from the community.

Page 46, Minutes October 27, 2011 Mr. Mora reported that he and Dennis Curtis had met with El Segundo Mayor Eric Busch and Mayor Pro Tem Bill Fisher on October 27, 2011 and that El Segundo is motivated to assist the Wiseburn School District in securing land for the high school. They both, Mr. Busch and Mr. Fisher, reiterated that they were not in favor of a Wiseburn High School on the Campus El Segundo site.

From the Board (Cont'd.)

Mr. Mora expressed that there are problems with the restrooms at Dana Middle School being locked during the weekends and people using different parts of the campus as a bathroom facility. Mr. Mora asked staff to look into this as it potentially creates a health issue.

Mr. Mora also mentioned that there are times over the weekend that our gates remained locked so AYSO teams have been having to climb the fence. Mr. Mora requested that we talk to the coaches and team moms to address this issue.

Mr. Martinez reported that he had attended the Picnic at Anza on October 14, 2011. Mr. Martinez expressed his thanks to the parents and staff members who put this great event together. Mr. Martinez reported that he and Mr. Bañuelos had attended a facilities meeting on October 10, 2011 to get the Multipurpose Room Project back on track.

Mr. Cox reported that the audit team had been in the District all week completing audits for both the Wiseburn School District and the Da Vinci Charters. The audit report will be presented to the Board in January. Wiseburn will have a clean audit and the Da Vinci Charters have some minor clean-up issues involving their enrollment accounting procedures.

From the Chief Business Official

Mr. Cox reported that we would be going out to bid with four or five companies on the MultiPurpose Room Project at Peter Burnett School. The process is restarting and the target date for the beginning of construction is March 15, 2012, with an expected completion by Christmas 2012.

Mr. Cox reported that the 7/11 Committee that was established to deal with the District's surplus property on Utah Avenue had their first meeting on October 24, 2011. We had a very productive meeting and there will be another meeting on November 7, 2011 to conduct a public hearing on the sale of the property, approve a final determination of disposition of the Utah property and approve the final report and recommendation to the Board of Education. The 7/11 Committee's recommendation will be presented to the Wiseburn School Board at the November 17, 2011 meeting.

Dr. Johnstone shared newspaper articles from the Daily Breeze on Hawthorne Middle School's very successful programs, an article on the Aviation Station Project, and an article indicating that the Los Angeles Unified School District (LAUSD) will begin their school year on August 14, 2012.

From the Superintendent

Dr. Johnstone reported that he had received a letter from State Senator Joseph Simitian who is requesting that school districts pass a resolution in favor of a 55% majority vote for the passage of parcel taxes to support education. Currently a two-thirds vote is needed. Dr. Johnstone shared a sample resolution with the Board.

Dr. Johnstone shared the SARC report with the Board, which indicated that public usage of our web site and accessing School Accountability Report Card information. Our SARC reports are published by SchoolWise Press and have been an effective recruitment tool for us.

Dr. Johnstone shared that the Big Bang Orchestra involving approximately 50 Wiseburn students was doing very well and that the Salad Symphony would be occurring on November 5, 2011, at Lennox Middle School featuring almost 1,000 people using vegetables as percussion instruments.

Dr. Johnstone reported that the Great California Shake Out Drill on October 20, 2011 went very smoothly, and it provided an excellent opportunity for all of our schools to further fine

tune and refine their outstanding earthquake preparation.

From the Superintendent (Cont'd.)

Dr. Johnstone shared that also on October 20, 2011, Dennis Curtis, Nelson Martinez, Israel Mora and he had attended the Hawthorne Community Dinner, which raises funds to support needy families during the holidays.

Dr. Johnstone reported that he had attended TEDx in Manhattan Beach on Saturday, October 22, 2011. The focus of this TEDx session was the future of education in the United States and the need to refocus on the arts and creativity.

Dr. Johnstone reported that State Board Member, Ilene Straus visited Wiseburn on October 25, 2011 and had the opportunity to meet with Dr. Johnstone and Dr. Wunder and visit Da Vinci Science, Dana Middle School and take a car tour of the rest of the district.

The item related to minutes was tabled and will be brought to the November 17, 2011 meeting.
