- 4) Review of Current Projects:
 - a. Burnett School Multipurpose Room:
 - i. State matching money:
 - 1. Application for State Funding for Burnett MPR was submitted & approved by State Allocation Board.
 - 2. Status of application: "Unfunded Approval" (near top of unfunded list).
 - 3. Expect to receive \$1.5 million in state funding after next state bond sale. Last time the state sold bonds was March 2012.
 - ii. Burnett MPR expected completion date: October 31, 2012.
 - b. Cabrillo sinkhole lawsuit
 - i. Wiseburn School District paid what it owed (\$150,000 + \$25,000), received reimbursement from CW Driver (\$12,000) and Flewelling & Moody (\$12,000).
 - c. Sale of Utah property:
 - i. Escrow will close in 1-2 weeks.
 - ii. Sale price =-\$6.5 million. Wiseburn School District will receive 25% as down payment, remainder in 3 year note.
 - d. Technology infrastructure upgrade at Anza.
 - e. Dana School Snack Stand
 - i. Construction complete, waiting for Health Department permit.
 - ii. Reimbursement from sports leagues: When will Wiseburn School District start collecting \$\$ from leagues? May not need to if Measure CL passes. Will discuss reimbursement at next Recreation Committee meeting. Leagues will buy appliances.
- 5) Future Projects:
 - a. May need to borrow \$3-4 million from Measure A fund to purchase property for High School.
 - Demolition of old Dana school and creation of west playfields (after High School is built) -Target date: 2015/2016 school year.
