- 5 MODERNIZE science, computer, and engineering labs** to support 21st century instruction.
- 6 IMPROVE access to student mental health services.**
- 7 REPAIR deteriorating classrooms and facilities.**
- 8 PROVIDE clean, safe sports fields.**
