REGULAR MEETING BOARD OF TRUSTEES WISEBURN UNIFIED SCHOOL DISTRICT

April 14, 2016

The Regular Meeting of the Board of Trustees was called to order at 5:00 p.m. by Israel Mora, President, in the District Board Room in honor of Larry Rudolph, Lawndale City Councilman and Little League Coach who passed away this month.

The Board entered closed session at 5:01 p.m. and reconvened at 6:05 p.m. There was no reportable action during Closed Session.

Closed Session

The Pledge of Allegiance to the Flag was led by Ms. Dee Dee Zirbel.

Cabrillo School provided their annual presentation to the Board, which this year focused on the COTSEN Foundation funded professional development for mathematics. Teachers on the Cabrillo COTSEN team are First Grade teacher, Jen Williams, who is the mentor coach this year, Kindergarten teacher, Dee Dee Zirbel and First Grade teacher, Liza Hough. Other COTSEN teachers not present for the Board meeting are First Grade teachers Lori Cariaga and Lissette Ochoa and Cara Nakama in Second Grade. Jennifer Williams explained her role as the mentor coach.

Special Presentation

The COTSEN model of professional development provides a mentor to work with five to seven teachers. The mentor coach plans, observes and debriefs lessons with each teacher on a weekly basis. The mentor also researches best strategies, leads monthly inquiry meetings and attends trainings.

Ms. Williams showed student videotapes of several of the COTSEN strategies demonstrating how Cognitively Guided Instruction (CGI) interacts with kids. CGI focuses on mental math and ensures that students have a conceptual understanding of the math they are learning. Students decompose numbers, solve problems in different ways, persevere and take on challenging problems. The COTSEN teachers shared that the collaboration with other teachers has been phenomenal and that this experience has completely transformed the way they teach.

The Board had several questions for the COTSEN team and overall they were extremely impressed with the presentation.

Mr. Bañuelos shared his praise for both Laura Sullivan and Margaret Lynch and the Burnett and Cabrillo staffs for their State recognition with Gold Ribbon awards. The award ceremony will take place on May 24, 2016 at the JW Marriott in Downtown Los Angeles.

From the Board

Mr. Bañuelos shared that he had attended the Sea Perch Underwater Robotics Competition at the Hawthorne pool. Our Dana Middle School team of 5 students competed against scores of

Page 134, Minutes April 14, 2016 other middle schools and high schools from throughout Los Angeles County. Overall, our team was ranked very high in all categories. Mr. Bañuelos thanked Mr. Andy DeSeriere for his outstanding work with this program.

From the Board (Cont'd.)

Dr. Goldman congratulated both Cabrillo and Burnett for their Gold Ribbon honors.

He thanked Dr. Johnstone and Ana Montes for their continued work with the Health Care Committee.

Dr. Goldman congratulated Dr. Chris Jones as the ACSA Region XIV Central Office Administrator of the Year.

Ms. Kaneda thanked the Cabrillo COTSEN team and Margaret Lynch for their outstanding CGI presentation. She expressed that she is so proud that Wiseburn is a part of this and recognizes that a great deal of work goes into this on the part of our teachers.

Ms. Kaneda thanked Vince Madsen for the fabulous tour of the quickly developing Wiseburn High School site and she expressed her great pride in this tremendous accomplishment.

Ms. Kaneda closed asking Dr. Johnstone to provide a brief update on the Choice Blocks.

Mr. Mora thanked Vince Madsen for the wonderful tour of the high school construction project. He expressed that it was great to have Annie Aung back from her maternity leave. He expressed satisfaction and optimism that the construction project is still on schedule for completion by June 15th of 2017.

Mr. Wilson shared information from School Services regarding the level of budget reserves for unified school districts, elementary districts and high school districts. Overall, reserve levels across the State are falling, while in Wiseburn, the reserve levels are slightly on the rise.

From the Chief Business Official

Mr. Wilson also shared with the Board the most up-to-date information about the refinancing of school bonds. The bond refinance is one of the best that Wiseburn has ever had and will save Wiseburn taxpayers \$7,000,000 over the next two decades.

Dr. Jones provided the Board with an update on the new textbook materials adoption process for English Language Arts and English Language Development. This is the first time in 14 years that the District has considered a new adoption for ELA.

From the Deputy Superintendent

In closing, Dr. Jones shared that he was honored to be able to join 40 female students from Da Vinci Science and Dana Middle School on an engineering field trip to Cal Poly San Luis Obispo on March 29, 2016. This field trip is a perfect example of the wonderful collaboration that is occurring between our K-8 students and our high school students.

Mr. Madsen shared that the District will be receiving back-check documents from the Department of the State Architect on May 6, 2016 for fire-life-safety and structural.

From Director of Facilities Planning

Mr. Madsen shared that Dr. Johnstone and he had met with representatives of the property behind the high school at 200 Nash to discuss the placement of a power pole in the easement between the two properties. This process is moving along and significant progress has been made.

Dr. Johnstone shared the bookmarks with the Board that 3rd grade Anza Student Roland Lewis won in the 35th Annual Bookmark Contest. The Board members were very appreciative of these beautiful bookmarks.

From the Superintendent

Dr. Johnstone shared that he would be inviting the winners of the Spelling bee and Geography Bee to the April 26, 2016 Board meeting. Dr. Johnstone shared that Clayton Skaggs, who won the Wiseburn Spelling Bee made it to the fourth round of the Los Angeles County Spelling

Dr. Johnstone shared that there are two Board dinners coming up. One is the LACSTA event in Pasadena on April 25, 2016 and the second is the Celebrating Excellence Event in Downey on May 19, 2016.

Dr. Johnstone shared that through the efforts of Nelson Martinez and Roger Banuelos, the County Superintendent Dr. Arturo Delgado will be able to host the Nick Vujicic Anti-Bullying Event at the Forum in Inglewood on Monday, October 10, 2016.

Dr. Johnstone shared that he, Vince Madsen and Israel Mora attended the El Segundo State of the City Luncheon. Mayor Fuentes shared that wonderful world class education is going on in both of El Segundo's Unified School Districts.

Dr. Johnstone shared that the Arts Committee has completed the Strategic Arts Plan for the next five years between 2016 and 2021. Dr. Johnstone thanked Cybele Garcia-Kohel and Dr. Neil Goldman for all of their support and guidance through this process.

In closing, Dr. Johnstone shared that he would be attending the Future Ready Conference in Redondo Beach on April 14-15, 2016 and that he would be participating in the ShareFest Golf Tournament on April 15, 2016.
